Further course of action on their appointment will be taken by Principal Chief Personnel Officers of N.E.Railway Gorakhpur after due verification & ensuring fulfilment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste, PwBD, Past Character/antecedents/Affidavits etc. where necessary according to the Centralised Employment Notice No.03/2018 and corrigendum issued thereto from time to time and for which the candidates will be informed individually by the N.E.Railway Gorakhpur. All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate etc, as the case may be, are genuine and valid.

**3. The Appointment of candidates shall be subject to Medical fitness after Re-Medical Examination to be conducted by N.E.Railway Gorakhpur, as the case may be.**

Candidature of all the above candidates appearing in provisional Part panels is purely provisional and is liable to be cancelled in case of any inconsistency/deficiency of the data furnished by them in the online application or any mal-practice on the part of candidate coming to the notice of RRB at any stage of appointment/recruitment process, even after their appointment in Railways.

**5. It may be noted that merely getting place in the result and provisional panels does not entitle the candidates in any way to an appointment in the Railways.**

6. While every due care has been taken in preparing provisional Part panels, RRB reserves the rights to rectify any inadvertent error or typographical/ printing mistakes.
